Guidance for BTh Students

Candidates for the First Examination shall take:

- (a) A language paper from Group A (unless the candidate has previously undertaken a biblical language course successfully and has been granted an exemption from the Faculty Board)
- (b) **3.5** papers (or equivalent combination of full and half papers) from Groups B and C
- (c) Paper 51 (Practical Theology: Reflective Practice A)

Candidates for the Second Examination shall take:

- (a) An additional language paper *may* be taken from Group A (bringing the overall paper total to 6)
- (b) **Four** full papers (or equivalent combination of full and half papers) from Groups C and D OR **three** full papers (or equivalent combination of full and half papers) **plus** a dissertation of 8-10,000 words
- (c) Paper 52 (Practical Theology: Reflective Practice B)

Guidance for DTM Students:

Candidates shall be required to offer 4.5 papers, or the equivalent combination of papers and half-papers, from the following options, comprising:

- (a) a total of three papers drawn from those specified for the B.Th. Degree in Groups A, B, C, and D;
- (b) Paper 51 – Practical Theology: Reflective Practice (Group E); Candidates who have already received academic credit for a theological reflection upon a ministry placement may, subject to the approval of the Faculty Board, be exempted from the requirement to take Practical theology: Reflective Practice A and may substitute another half paper from Groups A, B, C, and D under regulation 11 for the BTh Degree in its place. The candidate must provide evidence for this exemption from their previous educational institution or denomination to the DoS of their Federation House; and
- (c) a dissertation on any topic, approved by the Faculty Board, relating to the subject of any full or half-paper from among those specified for the B.Th. Degree, as specified under Regulation 17 for the Bachelor of Theology Degree, which shall count as one paper.
